The data are not subject to transfer to a third country, however, the Data Controller reserves the possibility of using cloud-based IT services and in this case the service providers will be selected among those who provide adequate guarantees, as provided for in Article 46 EU Regulation 2016/679.

Retention period

Data will be kept for a period of time not exceeding the achievement of the purposes for which they are collected and processed, in compliance with the terms prescribed by law. Accounting regulations provide for the retention of data for 10 years after the end of the contractual relationship.

Rights of the data subject

The data subject, by contacting the Data Controller at the addresses indicated, has the right to obtain confirmation as to whether or not personal data concerning him or her is being processed, and in this case he or she has the right to request:

- request confirmation of the existence or otherwise of his personal data;
- obtain indications as to the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, when possible, the storage period
- obtain rectification, integration and deletion of data;
- obtain the restriction of processing;
- obtain, where applicable, portability of data, i.e., receive them from the data controller, in a commonly used structured format and transmit them to another data controller without hindrance;
- object to the processing at any time;
- object to automated decision-making relating to natural persons, including profiling.
- To file a complaint with the Privacy Guarantor in case of irregularities found in the processing.
